**PUBLIC COMMENT**

Individual citizen comments are normally limited to three minutes;** however, time limits can be adjusted by the presiding officer. The presiding officer may ask the citizen to hold their comment on an agenda item until that agenda item is reached. The Zoning Board of Adjustment has no obligation to respond in any manner to comments or questions from the public. Any response from a member of the Zoning Board of Adjustment to non-agenda comments is limited to a statement of specific factual information, a recitation of existing policy, or direction to staff to place the subject on the agenda for a future Zoning Board of Adjustment meeting.)*
