The Zoning Board of Adjustment has no obligation to respond in any manner to comments or questions from the public. Any response from a member of the Zoning Board of Adjustment to non-agenda comments is limited to a statement of specific factual information, a recitation of existing policy, or direction to staff to place the subject on the agenda for a future Zoning Board of Adjustment meeting.)*
