PUBLIC COMMENT

(The purpose of this item is to allow citizens an opportunity to address the Zoning Board of Adjustment on items that are listed on the agenda, or issues that are not listed on the agenda (non-agenda comments). Any person desiring to make a public comment must first be recognized by the presiding officer, and sign in at the podium with their name and address. Individual citizen comments are normally limited to three minutes; however, time limits can be adjusted by the presiding officer. The presiding officer may ask the citizen to hold their comment on an agenda item until that agenda item is reached. The Zoning Board of Adjustment has no obligation to respond in any manner to comments or questions from the public. Any response from a member of the Zoning Board of Adjustment to non-agenda comments is limited to a statement of specific factual information, a recitation of existing policy, or direction to staff to place the subject on the agenda for a future Zoning Board of Adjustment meeting.)

Public hearing and consider granting a variance to the Zoning Ordinance, allowing for a single-family lot that does not meet front yard setbacks at what is proposed to be Lot 7, Block 1, The Reserve at Bridgeport, at property described as being approximately 41.008 acres in the J.M. Arocha Survey, Abstract Number 18, located in the City of Bridgeport, Wise County, Texas.

4. Public hearing and consider granting a variance to the Zoning Ordinance, allowing for a single-family lot that does not meet side yard setbacks at what is proposed to be Lot 8, Block 1, The Reserve at Bridgeport, at property described as being approximately 41.008 acres in the J.M. Arocha Survey, Abstract Number 18, located in the City of Bridgeport, Wise County, Texas.
